- D. Discuss and take action: Revise the Building Ordinance.
  - Chris Goodwin motioned to revise building ordinance per discussed items and add tiny home(s) into building ordinance.
    - Building & Tiny House Ordinance

 Any structure built or moved in inside Hardin City Limits designed or being built for human occupancy must be built to HUD Standards.
 Signs need to have building permits and follow the requirements in the ordinance

**3.** NO RVs hooked to sewer unless at an RV Park with exception - RV's can only be inside city limits and hooked to the sewer if you have a building permit and sewer permit to build a home. When the building permit expires in 1 year then the council will have to approve it to be reissued with 3-month extensions at full cost of permit price. No RV's outside of RV Park without building permit.

**4.** Chris Goodwin motioned to revise building ordinance per discussed items and add tiny house ordinance into building ordinance

- E. Discuss and take action: Tiny House Ordinance.
  - Discussed above in item D.
- F. Discuss and take action: Protocol for homes that are on the sewer system but that are not in the city system.
  - Chris Goodwin motioned to set up a protocol to set up homes found on the sewer service.
    - 1. Charge back customer that is found on the sewer that has not paid.
    - 2. Go back 2 years of service and offer payment plan.
      - a. 6 months to pay off through a payment plan for all service charges
      - b. Pay right away charge 1/2 of service charges
    - Brett Clark offered a second.
  - All in favor
- G. Discuss and take action: Charge back customers for repairs on their side for sewer parts.
  - Brett Clark motioned to charge back customer for repair(s) on their side for parts and labor. \$50.00 minimum after 1<sup>st</sup> repair not to exceed \$500.00.
